The appointee shall report to Deputy Chief Medical Officer's Office Anantnag within 07 days from the date of issuance of this order, failing which he shall forego his right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of following certificates (in original) to be verified subsequently.

- Academic/qualification certificate.
- Matriculation /Date of Birth certificate.
- Health certificate issued by the Chief Medical Officer.
- Domicile Certificate issued by the competent authority.
- That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile Distt., He shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of

- proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- vi. Relevant Category Certificate (s) (In case of candidates belonging to reserved categories).
  - vii. Any other certificates/documents as required under rules/norms.

**The appointment of the candidate(s) shall further be subject to the following conditions:-**

- a. The appointee shall furnish an undertaking in the shape of an Affidavit to the effect that if on verification, his qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities are found fake/forged his appointment as Junior Health Inspector shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory report in respect of genuineness of qualification/date of Birth/relevant Category Certificate is received from the concerned Authorities/Agency.
- c. The appointee shall also furnish an undertaking in the shape of an affidavit to the effect that he is not working in any Govt./Semi Govt. Department/Organization from the date joined in the Directorate of Family Welfare, MCH & Imm. J&K
- d. The appointee shall be on probation for a period of two years.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated. 24.12.2009.
- f. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the J&K Service Selection Board.
- g. The appointment of the above appointee shall be subject to outcome of writ petition if any, pending before competent Court of Law.
- h. The appointee shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in this appointment order.
