- To ensure that only trained professionals as per the requirements are conducting MTPs in approved facilities (Govt/Private) in their respective jurisdictions.
- To approve the Institution/place (Govt/Private) for the said cause after assessing the availability of trained Medical Professional and necessary equipment's under the MTP rules.

- To make regular inspections of approved Institutions/place (Govt/Private) from time to time or as felt necessary for the safety of the women.
- 5. Issuance of Certificate of approval to the Institution/place (Govt/Private) in the prescribed format for the said procedure.
- To suspend the approval certificate of the Institution/place (Govt/Private) on the report of the Chief Medical Officer.
- 7. To reapprove the suspension after assessing the improvements made in the Institution/place by the owner.
